# Manufacturer's Warranty Statement (Policies)

## Standard Limited Warranty and Limited Lifetime Warranty

Solar Royal, LLC's ("Manufacturer")(Warranty Statement/Policies) [Solar Attic Fans, Solar Powered Fan Ventilation Attic Fans] solar powered fan ventilation systems and products are carefully built to exact specifications, tested and packaged with great care. Manufacturer herein warrants that its solar powered ventilation system(s) and product(s) are free from defects in workmanship, parts and/or materials as defined below. "Defects" as used in the warranty statement is defined as imperfections that impair the functionality of the product. The Solar Royal item 'SR1800 Series' has a standard fifteen (15) year full component warranty (motor, solar panel and housing) and available (upgradable-to) a limited lifetime warranty or limited warranty as defined by applications types; residential or commercial.

Manufacturer's standard warranty and available Limited Lifetime Warranty applies to installations on registered residential properties defined as single-family homes (dwellings). When used in commercial applications, commercial shall be defined as registration for commercial, multifamily, utility, industrial, agricultural, government, military and/or any applications other than on a single residential property, home or dwelling. Solar Royal warrants item 'SR1800 Series' to be free from defects in workmanship, parts and/or materials for a period of fifteen (15) years on all components (motor, solar panel and housing). Warranty is only valid when registered information is provided for the residential or commercial location (address) and under property owner or renter complete information. Warranty is not extended to the sales agent, dealer, partner, distributor or installer but through the registered endusers property information (provided during registration) and when registered within 90days of installation on property. If a warranty card was missing or not provided with the product, it is the registered users responsibility to register online or contact Solar Royal, LLC to make sure the purchased product is registered within ninety days (90) of completed installation. Both residential and commercial warranties are non-transferable and cover the original installation locations only. Any alterations of the product will void the warranty. No other party or entity, including, without limitation, subsequent purchasers or owners of the product shall have or be entitled to assert any rights or benefits herein.
