Solar Royal, LLC. certifies that the listed products are "Solar Electric Property" as defined by IRS Notice 2009-41, "Credit for Residential Energy Efficient Property" as prescribed in the American Recovery and Reinvestment Act of 2009 and therefore qualify for the Federal 30% tax credit provided the installation occurs between January 1, 2011 and December 31, 2016, which now has been extended to 2019. After 2019 the tax credits steps down to 26% for 2020 and will step-down to 21% for 2021.

Updated: "The Residential Clean Energy Credit equals 30% of the costs of new, qualified clean energy property for your home installed anytime from 2022 through 2032. The credit percentage rate phases down to 26 percent for property placed in service in 2033 and 22 percent for property placed in service in 2034. You may be able to take the credit if you made energy saving improvements to your home located in the United States."
